- Maintain routine veterinary care.
- Provide safe, clean, and humane housing.
- Treat the puppy with kindness and responsible lifelong care.

TRANSFER OF OWNERSHIP

Ownership of the puppy transfers to the Buyer only after the purchase price has been paid in full and the puppy has been delivered.
